

Compliance is a major policy in our company and applies in all our projects, from the materials handling, procurement and any other aspect we work on.




Occupational Health and Safety and Environmental Management


NATIONAL FOOTPRINT

Ted is well respected in the industries that he has worked in and comes with so much experience in the IDH stable.


Tshepo Letsoale
